Eligibility

- You must be a residential natural gas heating customer of a participating GasNetworks utility.
- Rebate is for replacement windows only.
- Window(s) must be ENERGY STAR – labeled.
- Window(s) must have a U-factor of .35 or less.
- Rebate is valid for purchases and installations made between December 1, 2008 and December 31, 2009.
- Rebate does not apply to new home construction or additions.
- Applications must include a dated receipt/invoice noting completion of installation.
- You must include a copy of the NFRC* label for each window.
- Work is subject to post-installation verification.
- Additional restrictions may apply.

1. What is GasNetworks?

Window(s) installed between December 1, 2008 and December 31, 2009 are eligible. Window(s) must have been installed at the installation address on the front of the application. Rebate is for replacement windows only. Application and required documents listed must be received by GasNetworks within 30 days of installation.

Installation Verification: Prior to honoring any rebate, GasNetworks reserves the right to conduct an on-site verification that the windows were installed according to the guidelines of the program. It does not include any kind of safety or code compliance review and should not be relied upon as such.
